The last registered 6.7 quake, centered in the San Fernando Valley in 1994, caused some \$25 billion damage, injured more than nine-thousand people, and impacted thousands of businesses for years. Most believe that jobs cannot provide a secure economic future in a time of rapid technological change...and are aware that small businesses (less than 500 employees) have created more than 90% of the net new jobs in the U.S. over the past twenty years... Millennials are well equipped for work in a high-tech world, but have little interest in their employers' needs and, instead, a powerful urge to do things their own way."

- 'DEPRESSION' IN THE WORKPLACE, beyond the toll it takes on an employee and his/her family and friends, can materially impact co-workers and a company's operational performance. Causes of depression include genetic predisposition and brain chemistry, but also often include stress, isolation and other aspects of the *workplace environment* – particularly in professional firms where stress and isolation are commonplace (e.g. "lawyers suffer the highest rate of depression, nearly four times the rate of the general adult population"). Proactive steps to minimize the adverse influence of work environment include "promoting work-life balance, ...encouraging interaction and collaboration, ...facilitating social events, ...encouraging healthy lifestyles, ...and, above all else, not ignoring the employee who shows signs of depression: a persistently sad or irritable mood; difficulty thinking, concentrating and remembering; physical slowing or agitation; lack of interest in or pleasure taken from activities that were once enjoyed; increased absenteeism; decreased productivity and missed deadlines; indecision or poor judgment; mood swings or other erratic behavior, such as uncharacteristic outbursts of anger; unusual anxiety or complaints of constantly feeling tired... Be willing to encourage your people to seek assistance and to support them as they do."
